

# FITTING INSTRUCTIONS

- Bolt the adaptor plates (Items 2 & 3) and Spacers (Items 4 & 5) to the OE rack (4x threaded holes) using the M8 button head bolts (Items 7 & 8) as shown in the Assembly Diagram. It is a good idea to apply a drop of Loctite 242 to the bolts before installation in order to prevent them from coming loose due to vibration.
- Place the rack plate (**Item 1**) on top of the brackets and secure to the brackets with the M8 countersunk bolts (**Item 2**).

- To fit a SHAD Terra topbox to the rack you will need R&G kit ARSHAD0001
- GIVI Trekker Outback topbox requires SW-Motech part no. GPT.00.152.35400/B
- SW-Motech TRAX ION/ADV/EVO requires SW-Motech part no. GPT.00.152.35100/B



- Vissez les plaques d'adaptation (articles 2 et 3) et les entretoises (articles 4 et 5) sur le support d'origine (4 trous filetés) à l'aide des boulons à tête bombée M8 (articles 7 et 8) comme indiqué sur le schéma d'assemblage. Il est conseillé d'appliquer une goutte de Loctite 242 sur les boulons avant l'installation afin d'éviter qu'ils ne se desserrent en raison des vibrations.
- Placez la plaque de support (article 1) sur les supports et fixez-la aux supports avec les boulons à tête fraisée M8 (article 2).
