

FITTING INSTRUCTIONS

- Remove the 6x M6 bolts holding the OEM plastic rear rack in place.
- Bolt the adaptor plates (Items 2 & 3) and to the bike using the 6x M6 OEM bolts you removed in step 1 (See Picture 1). It is a good idea to apply a drop of Loctite 242 to the bolts before installation in order to prevent them from coming loose due to vibration.
- Place the rack plate (Item 1) on top of the brackets and secure to the brackets with the M8 countersunk bolts (Item 4).

- To fit a SHAD Terra topbox to the rack you will need R&G kit ARSHAD0001
- GIVI Trekker Outback topbox requires SW-Motech part no. GPT.00.152.35400/B
- SW-Motech TRAX ION/ADV/EVO requires SW-Motech part no. GPT.00.152.35100/B



NOTICE DE MONTAGE

- Retirez les 6 boulons M6 qui maintiennent le porte-bagages arrière en plastique d'origine en place.
- Vissez les plaques d'adaptation (articles 2 et 3) à la moto à l'aide des 6 boulons M6 d'origine que vous avez retirés à l'étape 1 (voir l'image 1). Il est conseillé d'appliquer une goutte de Loctite 242 sur les boulons avant l'installation afin d'éviter qu'ils ne se desserrent à cause des vibrations.
- Placez la plaque de porte-bagages (article 1) sur les supports et fixez-la aux supports avec les boulons à tête fraisée M8 (article 4).

- Pour monter un topcase SHAD Terra sur le porte-bagages, vous aurez besoin du kit R&G ARSHAD0001
