
ITEM 1 = EXHAUST HANGER (HB0076) (x1).

ITEM $2 = M8 \times 25 \text{mm}$ LONG BUTTON HEAD BOLTS (x3).

ITEM 3 = M8 WASHER (x1).

TOOLS REQUIRED

- Set of metric Allen keys to include 5 & 6mm A/F sizes.
- Socket set to include 12mm socket & wrench.



Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

FITTING INSTRUCTIONS

• To fit the R&G Exhaust Hanger the OEM pillion footrest mounting bracket needs to be removed.

- Place two the button head bolts (item 2) through the top holes in the exhaust hanger (item 1).
- Offer the R&G exhaust hanger place into position and tighten into the thread on the sub-frame, as shown above.
- Place the remaining button button head bolt (item 2) with the washer (item 3) through the lower hole in the exhaust hanger and into the exhaust mounting bracket and secure as original.
- Ensure the exhaust hanger is correctly fitted before tightening all three bolts.
- Please ensure when the motorcycle is being used that no parts are in such a position that they may collide/damage other bike parts (this is particularly important if using after-market cans or exhaust systems).

Please note that it is your responsibility to ensure that no part of the exhaust hanger or exhaust assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.



- Pour monter le support d'échappement R&G, le support de fixation du repose pied passager doit être enlevé.
- Insérer 2 boulons (article 2) dans les trous supérieurs du support d'échappement (article 1).
- Monter le support d'échappement R&G en position puis serrer dans le filetage du sous-cadre, voir ci-dessus.
- Insérer le boulon restant (article 2) avec la rondelle (article 3) dans le trou inférieur du support d'échappement dans le support de fixation d'échappement puis fixer comme à l'origine.
- Veiller à ce que le support d'échappement soit correctement monté avant de serrer les 3 boulons.
- Vérifier qu'aucune partie de la moto ne puisse potentiellement heurter une autre partie de la moto lors de son utilisation (cela est particulièrement important si vous utilisez un pot d'échappement qui n'est pas d'origine).

Il est de votre responsabilité de veiller à ce qu'aucune partie du support de pot d'échappement ne puisse entrer en contact avec d'autres parties de la moto. 

You will also receive 4x spacers (S0379)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

TOOLS REQUIRED

- 5mm metric Allen key.
 - T45 Torx key.

Left-hand side (as you sit on bike)

- Using T45 Torx key remove the two bolts and remove rear footrest.
- Fit two of the counter sunk headed bolts through the blanking plate so head sits in counter-sink.
- Offer assembly up to bike and engage both bolts (depending on the size of the weld you may need to use the spacers from kit between the blanking plate and the frame).
- Tighten evenly using 5mm Allen key.

Right-hand side (as you sit on bike)

- Using T45 Torx key remove the two bolts and remove rear footrest.
- Fit two of the counter sunk headed bolts through the blanking plate so head sits in counter-sink.
- Offer assembly up to bike and engage both bolts (depending on the size of the weld you may need to use the spacers from kit between the blanking plate and the frame).
- Tighten evenly using 5mm Allen key.
