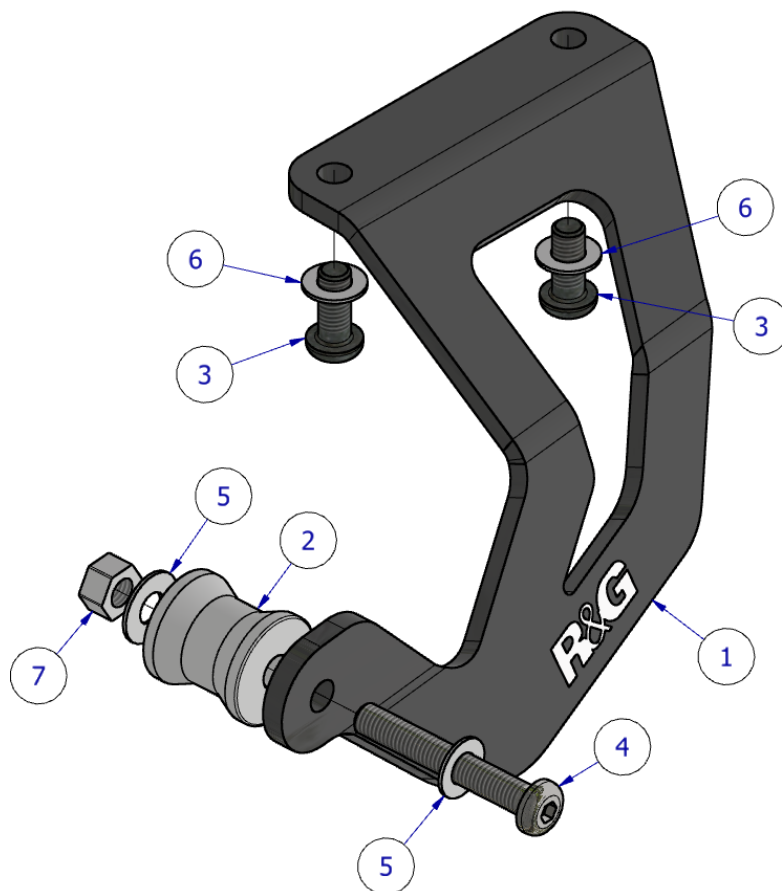

FITTING INSTRUCTIONS

- To fit the R&G Exhaust Hanger, the OEM pillion footrest mounting bracket needs to be removed.
- To do this, remove the two mounting bolts at the top of the pillion footrest mounting bracket then remove the OEM pillion footrest mount from the motorcycle.
- Fit one of the smaller washers (**item 6**) over each of the two shorter button head bolts (**Item 3**).
- Take the R&G Exhaust Hanger (**Item 1**) and fit the two M8 x 20mm long button head bolts (**Item 3**) through the two top mounts of the exhaust hanger as shown in the **assembly picture**.
- Offer the exhaust bracket into position and engage both bolts into the pillion foot peg mounting holes (do not fully tighten at this stage).
- The Spacer (item 2) can now be fitted between the exhaust hanger and exhaust.
- Following the **Assembly Diagram** on page 2, place the M8 button head bolt (**Item 4**) through one remaining washer (**Item 5**), spacer (**item 2**) & exhaust hanger mounting bracket.
- Pass the end of the bolt through the exhaust mounting hole on the exhaust bracket (between **items 2 & 5** on the Assembly diagram).
- Fit the remaining washer (**item 5**) and M8 Nyloc nut (**Item 7**) onto the exposed thread of the bolt and loosely tighten as shown in the **Assembly Diagram**.
- Ensure the exhaust hanger is correctly fitted before tightening all three bolts.
- Please ensure when the motorcycle is being used that no parts are in such a position that they may collide/damage other bike parts (this is particularly important if using after-market exhaust systems).

Please note that it is your responsibility to ensure that no part of the exhaust hanger or exhaust assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.

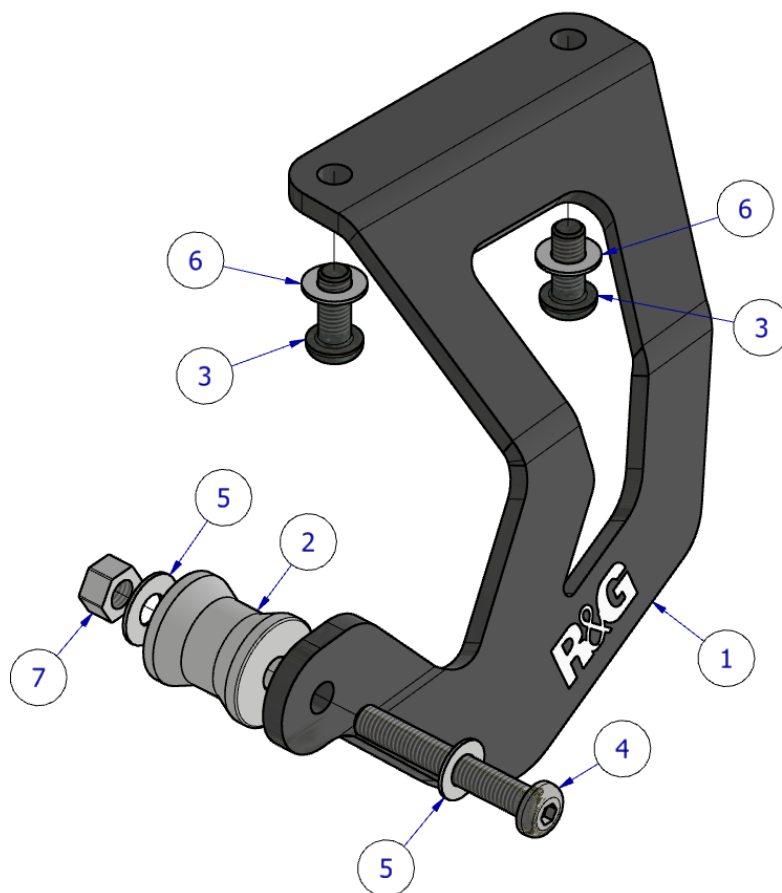

NOTICE DE MONTAGE

- Pour installer le support d'échappement R&G, le support de montage du repose-pied passager d'origine doit être retiré.
- Pour ce faire, retirez les deux boulons de montage en haut du support de montage du repose-pied passager, puis retirez le support de repose-pied passager d'origine de la moto.
- Montez une des rondelles plus petites (article 6) sur chacun des deux boulons à tête ronde plus courts (article 3).
- Prenez le support d'échappement R&G (article 1) et placez les deux boulons à tête ronde M8 x 20 mm de long (article 3) à travers les deux supports supérieurs du support d'échappement comme indiqué sur l'image d'assemblage.
- Présentez le support d'échappement en position et engagez les deux boulons dans les trous de montage du repose-pied du passager (ne serrez pas complètement à ce stade).
- L'entretoise (article 2) peut maintenant être montée entre le support d'échappement et l'échappement.
- En suivant le schéma d'assemblage à la page 2, placez le boulon à tête ronde M8 (article 4) à travers une rondelle restante (article 5), une entretoise (article 2) et un support de montage de suspension d'échappement.
- Passez l'extrémité du boulon à travers le trou de montage de l'échappement sur le support d'échappement (entre les articles 2 et 5 sur le schéma de montage).
- Installez la rondelle restante (article 5) et l'écrou nyloc M8 (article 7) sur le filetage exposé du boulon et serrez légèrement comme indiqué sur le schéma de montage.
