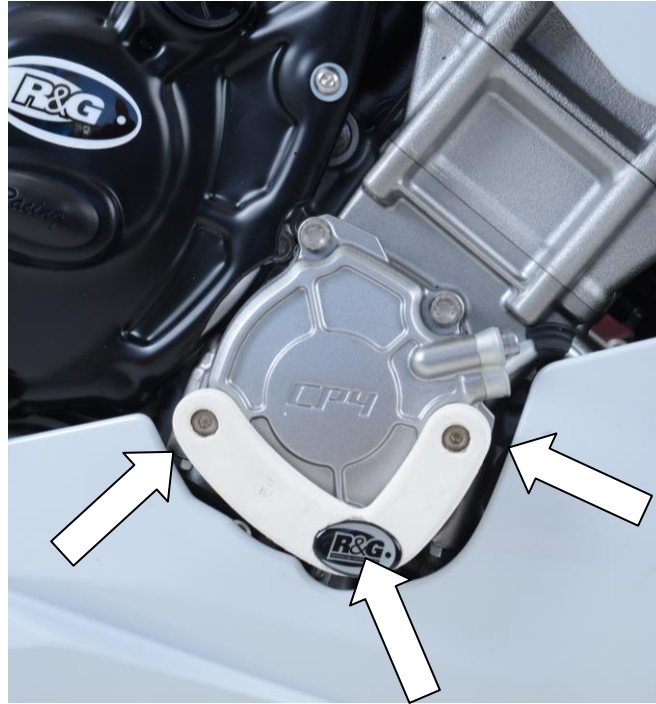


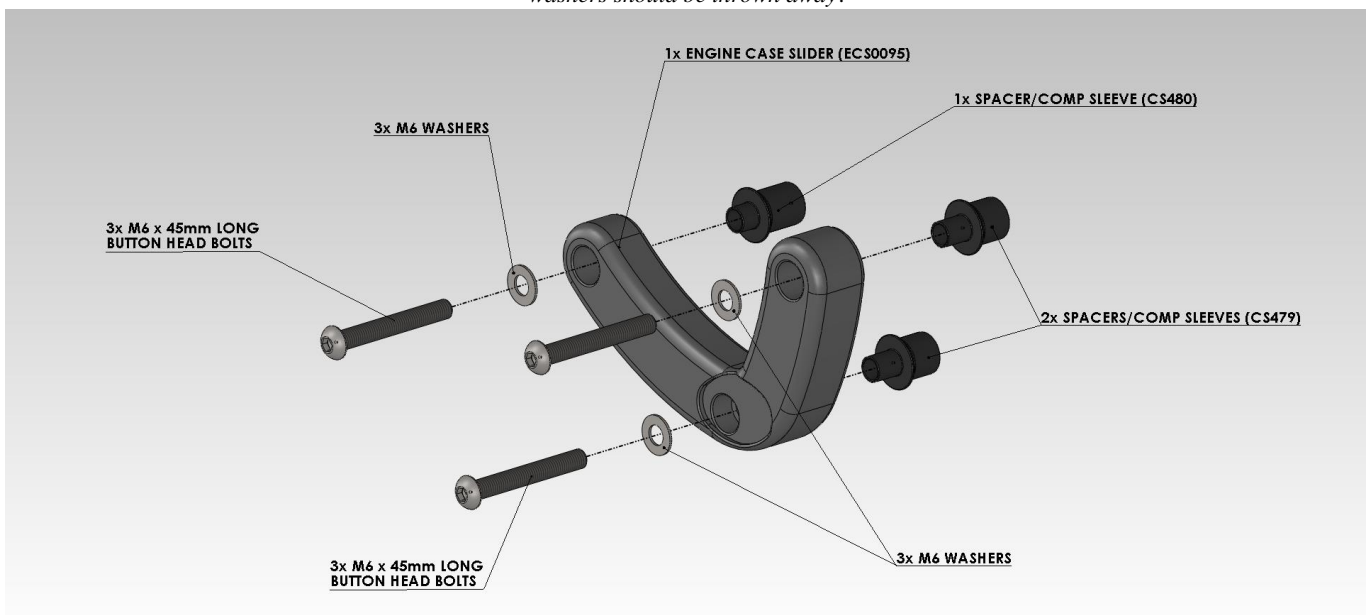


FITTING INSTRUCTIONS FOR ECS0095BK ENGINE CASE SLIDERS
YAMAHA YZF-R1 '15- (RIGHT HAND SIDE ONLY)



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*





Left-hand side (as you sit on bike)

- Remove the three M6 bolts as positioned (arrowed) above using a 12-point socket.
- Insert new button head bolts with washers through the slider.
- Offer up to bike.
- Tighten evenly to manufactures specified torque.
- Fit bubble sticker as shown above.

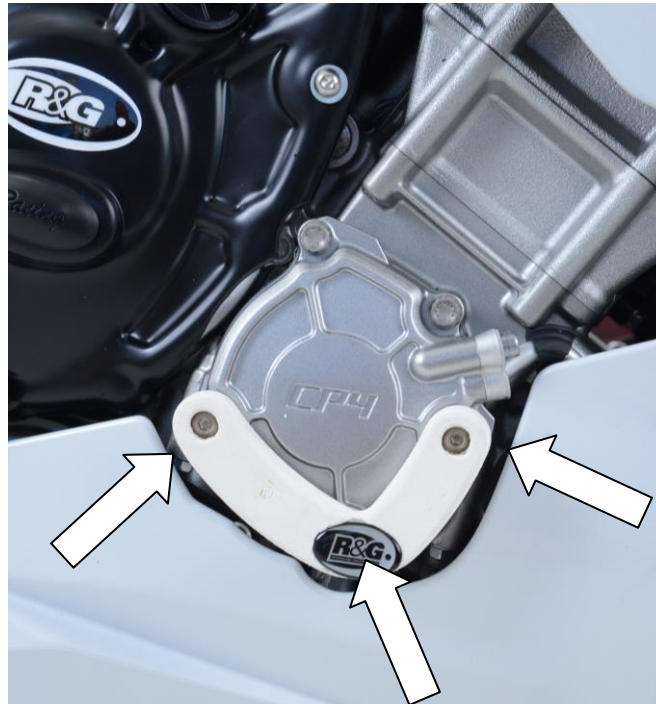

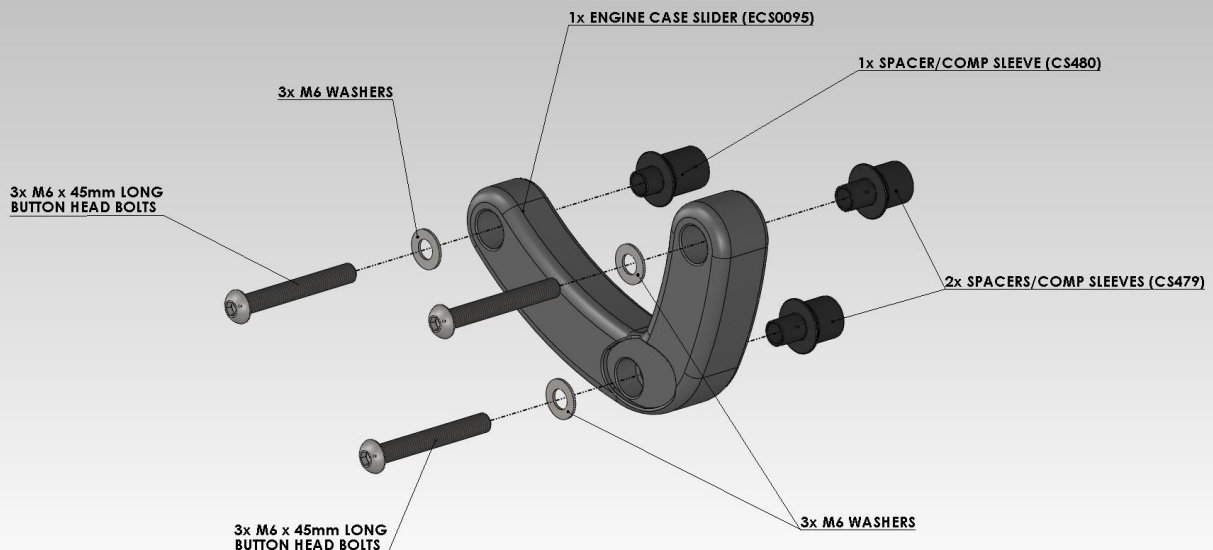


**Instructions de montage pour ECS0095BK Protection Carter Moteur
YAMAHA YZF-R1 '15- (Coté droit uniquement)**



La façon dont le kit est emballé ne correspond pas forcément à la façon de monter les pièces sur la moto.

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, *ces rondelles doivent être jetées!*





Coté droit (assis sur la moto)

- Enlever les 3 boulons M6 (fléchés sur le schéma ci dessus) en utilisant une prise de 12 points.
- Insérer les nouveaux boulons avec les rondelles à travers les sliders.
- Monter l'ensemble sur la moto.
- Serrer de façon identique, et aux couples spécifiques d'usine.
- Mettre les stickers en gomme R&G.
