

## Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with a plastic tube separating components on the spindle bar (this tube should be discarded).

## **TOOLS REQUIRED**

• Socket set to include 2x 8mm sockets and wrenches

## FITTING INSTRUCTIONS

- Fit one nut and washer onto the spindle bar and engage one nut so the plastic insert of the nut is fully engaged.
- Feed the spindle bar with the nut and washer fitted through the thicker frame insert (B0512) so the nut and washer go into the counter bore of the frame insert.
- Feed this assembly through the frame/swingarm pivot from the left hand side of bike.
- Place the remaining thinner frame insert over the exposed end of the spindle bar on the other side
  of the bike.
- Fit the remaining washer and nut from the kit onto the exposed thread and tighten until both nuts are engaged in the nylon and equal amounts protrude from either side. *Do not overtighten the nyloc nuts will hold it tight.*
- Fit the bubble stickers into the recess on both frame inserts.



## INSTRUCTIONS DE MONTAGE

- Passer un écrou et une rondelle sur l'axe, puis engager l'écrou pour que l'insert de plastic de l'écrou soit complètement engagé.
- Passer l'axe avec écrou et rondelle à travers l'insert de cadre le plus épais (B0512) pour que l'écrou et la rondelle aillent dans le contre alésage dans l'insert de cadre.
- Passer l'ensemble à travers le cadre/ pivot de bras oscillant du coté gauche de la moto
- Placer l'insert de cadre fin restant autour de l'extrémité de l'axe de l'autre coté de la moto.
- Passer la rondelle et l'écrou du kit sur le filetage et serrer jusqu'à ce que les 2 écrous soient engagés dans le nylon et que les longueurs dépassantes de chaque coté soient égales. Ne pas trop bloquer, les écrou fixent l'ensemble correctement.
- Placer les stickers de caoutchouc dans le creux des 2 inserts de cadre.
