T25 Torx driver.



FITTING INSTRUCTIONS

- To fit the radiator guard to the bike, cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame.
- Remove the upper radiator mounting bolt from the right side of the motorcycle as arrowed in picture 1.
- Remove both lower radiator mounting bolts as arrowed in picture 2.
- Offer the radiator guard into position and secure using the included bolts and washers.



- Pour monter la grille de protection radiateur, coupez les mousses en bandeaux 10mm de large et collez-les au bas du cadre de protection radiateur.
- Enlever le boulon supérieur de fixation radiateur du côté droit de la moto, voir photo 1.
- Enlever les 2 boulons de fixation radiateur inférieurs, voir photo 2.
- Monter la grille de protection radiateur en position puis fixer à l'aide des boulons et rondelles.



- Entfernen Sie die obere Montageschraube für den Kühler an der rechten Seite des Motorrades siehe Abbildung 1.
- Entfernen Sie die zwei unteren Montageschrauben am Kühler, die in Abbildung 2 mit Pfeilen gekennzeichnet sind.
- Den Kühlerschutz in Position bringen und mit den Schrauben und Unterlegscheiben vom Kit befestigen.
