- Remove the OEM bar end weight on the clutch lever side of the bike.
- Pre-assemble all components in the orientation shown in the assembly diagram, excluding the bolt cap.
- Place the assembly inside the bar end, ensuring not to inhibit any throttle action.
- Tighten the bolt until the assembly is secure in the bar. Do not exceed 15Nm of torque.
