



## **FITTING INSTRUCTIONS FOR SP0030BK SWINGARM PROTECTORS HONDA CROSS RUNNER 2011**



### **Near side (left side as you sit on bike)**

- Remove push in plastic cover from rear spindle.
- Place the protector over the rear spindle nut and secure using the three grub-screws.
