



## **FITTING INSTRUCTIONS FOR LP0021BK TAIL TIDY (LICENCE PLATE HOLDER)**

### **Kawasaki ER-6**

**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

- Remove seat
- Undo wiring loom to number plate light & flashers
- Undo the 4 nuts holding the tail unit to the bike & remove tail unit
- Take the R&G licence plate holder & fit to the bike using the 2 rubber spacers, 4 M6x30 button head bolts and the 4 nylon nuts supplied & tighten
- Fit the led number plate light and the indicators of your choice. If you use after market indicators use the blanking plates supplied.
- Reconnect wiring
- Note we suggest that you cut the plug from your original number plate light and connect it to the LED light supplied using the two splice connectors in the kit.

**If you plan to fit mini indicators to the rear of the bike only (not the front), you will need to source and fit your own resistor, in order to reduce the wattage.**

These terms do not affect the Buyer's statutory rights.

### **R&G RACING RETURNS POLICY (NON-FAULTY GOODS)**

Returns must be pre-authorized (if not pre-authorized the return will be rejected)

Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor.

Goods must be in re-sellable condition, in the opinion of R&G Racing.

All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase).

The customer must pay any and all carriage charges.

No returns of discontinued products, unless within 14 days of purchase.

This policy does not affect your statutory rights and does not refer to faulty goods.
